Membership Definitions

Affiliated Member – Affiliated to the AFF - Eligible to enter State and National tournaments and ACTFA programs. **Non Fencing Member** - Unable to participate in any fencing events.

Fencing Coaches – For fencing coaches – Able to enter National and State tournaments.

Non Fencing Coaches – For non fencing coaches. Not able to enter National and State tournaments.

Any Association Member over the age of 18 is eligible to vote

Beginners Registration – Registered with ACTFA for the purpose of Insurance only. Registered Beginners are not entitled to vote or take part in any competitions or programs provided by ACTFA, except specifically designated Beginner Competitions. Registration lasts 3 months only, after that if the fencer wishes to continue they will need to upgrade (pay the difference) to affiliated level.

INDEMNITY DECLARATION

I, the above signed, hereby agree that the ACT Fencing Association Inc., and the Australian Fencing Federation Inc., or any member thereof and/or any person associated in any way with the conduct of or participation in the competitions conducted by said Association or Federation (all of which persons, Association and Federation are severally and jointly included in the term "indemnified") shall not be deemed responsible or liable in any way for any injury, illness, or mishap to me sustained in, arising from or out of, or in any way directly, or indirectly connected with any travelling, match, practice or any function of whatsoever nature held in connection with competitions arranged by the "indemnified", or prior to or subsequent thereof, if in any way connected directly or indirectly with the said competitions and hereby indemnify the indemnified against any actions, suits, courses in action, demands and claims made by me.

I declare that I have read and understand the following FIE Rules which apply to all levels and training and competition which come under the auspices of the affiliated clubs, associations of the Australian Fencing Federation Inc., and the Federation itself:

FIE Rules for Competitions

CHAPTER 4. THE FENCERS' EQUIPMENT

(Weapons — Equipment — Clothing)

Responsibility of fencers t.15.

- 1. Fencers arm, equip and clothe themselves and fence at their own responsibility and at their own risk.
- 2. The safety measures specified in the Rules and in the standards contained in the annexe to them and the methods of control laid down in the present Rules (cf. Material Rules) are only designed to *reinforce* the fencers' safety and cannot *guarantee* it. They cannot, therefore, whatever the manner in which they are applied, impart responsibility to the FIE, or to the organisers of competitions, to the officials or personnel who carry out such organisation, or to those who may cause an accident.
